Recap of the October PMCC Meeting

Recap of the October 2023 PMCC Meeting

- ▶ Reviewed NCQA changes to existing measures in the WSCMS
- ▶ The committee voted to adopt the following changes:
 - ▶ Remove from WSCMS due to NCQA retirement
 - Ambulatory Care and Inpatient Utilization (AMB)
 - Use of Spirometry Testing in the Assessment and Diagnosis of COPD (SPR)
 - Pneumococcal Vaccination Status for Older Adults (PNU)
 - ▶ Updated the following measures due to changes in HEDIS specifications:
 - Hemoglobin A1c Control for Patients with Diabetes (HBD) updated to Glycemic Status Assessment for Patients With Diabetes (GSD)
 - Eye Exam for Patients with Diabetes (EED)
 - Kidney Health Evaluation for Patients With Diabetes (KED)
 - Colorectal Cancer Screening (COL) – moving to ECDS reporting only
 - ▶ Added Adult Immunization Status (AIS-E) to replace immunization measures previously collected through CAHPS

Recap of the October 2023 PMCC Meeting

- ▶ The Committee heard proposed recommendations from the 2023 PMCC Evaluation Workgroup
 - ▶ Convene listening sessions
 - ▶ Revisit the categories in the WSCMS
 - ▶ Select a few areas/measures to focus on
 - ▶ Consider reconvening the health equity ad hoc workgroup
- ▶ Learned about HIV prevention efforts in Washington State and discussed a request to add HIV Viral Load Suppression measure to the WSCMS
- ▶ Committee voted for the preliminary addition of the HIV measure to the WSCMS, pending public comment

HIV Viral Load Suppression Measure

HIV Viral Suppression Measure

- ▶ Originally considered as part of the original 2014 WSCMS
- ▶ Again, presented for consideration in 2016 at the recommendation of GSK/DOH
- ▶ The PMCC agreed it was important but put it in the parking lot due to insufficient data
- ▶ Is on the current CMS Adult Core Measure Set
- ▶ The committee was reminded that this topic has been discussed in the past but it was put into the parking lot due to a lack of a robust data source.
- ▶ Through participation in the NASTAD Learning Collaborative Washington is now able capture the data and it is currently being reported to CMS as part of the annual Core Measure Set reporting for Medicaid clients.
- ▶ We are now able to collect and report this measure

Public comment survey

- ▶ Survey was open from November 8 to December 1.
- ▶ There were replies from 3 people, who indicated they represented the following:
 - ▶ Consumer
 - ▶ Health Professional
 - ▶ Public Health Agency
- ▶ All 3 indicated their support for adding to the WSCMS

Public comment survey, cont.

Additional comments

- ▶ We need to have good tools in order to fight HIV/AIDS. This measure is essential in helping us to have all the tools we need.
- ▶ I have spent my nursing career at FQHC's and work closely with patients with HIV and those who are at risk. This measure would encourage organizations to put more effort into engaging these patients and providing resources and care management.
- ▶ This type of financial incentive will increase the level of priority.

Discussion

► Things to consider

- ▶ Data source:
 - Department of Health
- ▶ Impact:
 - Lower immune systems could lead to other high-cost conditions, such as cancer, heart disease, etc.
 - Potential cost savings due to suppressed HIV
 - *"Patients with HIV not receiving ART incurred the highest spending related to infections, mental health disorders, and other medical conditions compared with patients in other HIV subgroups receiving ART."**
 - Are already seeing a lower suppression rate in younger people
- ▶ HIV status can not be reversed but can be controlled
- ▶ Is it feasible to add as a reportable measure by health plans?
- ▶ Should we add the measure as a population health measure only?
 - Pros
 - Highlights the importance of the issue
 - Cons
 - Doesn't qualify as a VBP measure for state contracts
 - Only includes Medicaid population

HIV Viral Suppression Measure (HVL-AD)

▶ Measure Steward:

- ▶ Health Resources & Services Administration (HRSA)
- ▶ [National Quality Forum](#) #: 2082 / 3210e

▶ Description:

- ▶ Percentage of patients, regardless of age, with a diagnosis of HIV with a HIV viral load less than 200 copies/ml at last viral load test during the measurement year

▶ Numerator:

- ▶ Number of patients in the denominator with a HIV viral load less than 200 copies/ml at last HIV viral load test during the measurement year

▶ Denominator:

- ▶ Number of patients, regardless of age, with a diagnosis of HIV with at least one medical visit in the measurement year
